The Prinicpal Guest was Honorary Freeman of the Fuellers, Sir John Parker GBE FREng, who has served as CEO, Chairman or Non-Executive Director in over twenty major UK and overseas companies.

ir John was born into a farming family in Co. Down (Northern Ireland) and studied Naval Architecture and Mechanical Engineering at the Belfast College of Technology and Queens University Belfast.

He is currently Chairman of Laing O'Rourke Group and was until recently a Non-Executive Director of Carnival Corporation. He Chaired the Review of Government on "Ethnic Diversity in the Board Room" and recently completed "A Review of UK Naval Shipbuilding Strategy" for the MOD. He has chaired and been involved with several organisations, including serving as Chair of the Court of the Bank of England and President of the Royal Academy of Engineering.

He has also engaged in extensive voluntary work. He was Knighted in 2001 (Knight Batchelor) for Services to the Defence and Shipbuilding Industries and was appointed GBE in 2012 for Services to Industry and the Voluntary Sector.

With such esteemed company, attendees were given an insight into the remarkable worlds of those presenting during the evening, with our Master Elena Oderstone summing up: "The magnificent Woodmongers' Banquet was an unforgettable celebration of legacy, leadership and laughter."

Industry insights

The evolution of Carbon Capture, Utilisation and Storage (CCUS)

A group of Fuellers recently had the opportunity to visit Drax Power Station in Yorkshire. While Drax started operations in the 1970s, it was fascinating to learn more about the asset's transition from coal generation to a biomass facility, and the company's ambitions to develop a significant carbon capture operation targeting UK storage and exploring the growing opportunities for utilisation.

Carbon capture, utilisation and storage (CCUS) is an important aspect of industrial policy and decarbonisation strategy in the UK and beyond. Entities which are able to decarbonise are likely to have a competitive advantage compared to unabated domestic peers and international players which face similar obligations where carbon border taxes are imposed.

Like Drax, CCUS is an industry that has evolved significantly and is likely to change further into the future.

Many of the technologies that enable the capture and (pipeline) transport of carbon dioxide are not new: operational carbon capture projects date back over fifty years. The economic model that has underpinned these projects has largely been driven by crude oil prices with the captured CO₂ being injected into reservoirs as part of enhanced oil recovery (EOR) activities.

The understandable environmental concerns of a carbon capture model that results in increased fossil fuel production has led to an evolution of the CCUS landscape, which has been encouraged by both carrot (incentives) and stick (charges) approaches.

The UK has adopted elements of both: certain emitters are required to either limit their emissions to an allocated level or purchase certificates to cover the excess under the UK ETS (for further reading please refer to Participating in the UK ETS – GOV.UK); the UK government has also made available £21.7 billion of support over the next 25 years to launch a domestic CCUS industry (please refer to the press release at Government reignites industrial heartlands 10 days out from the International Investment Summit – GOV.UK). Government support models vary in different countries with other governments pursuing tax incentives or direct subsidies.

The 'value' of a CCUS project is a function of the price secured/ cost saved of the CO₂ plus any usage value, offset by the costs of capture, transportation and storage/utilisation. At current levels of cost and carbon pricing, many CCUS projects are not economical without some form of government support

to increase the price and/or reduce the cost. It is, therefore, understandable that a key question being asked by both governments and private companies is "How will the CCUS market evolve to become self-financing and profitable?"

The evolution of CCUS can be separated into two topics – creation of value from CO₂; and cost management. While governments need the entire value chain to function, some organisations are more focused on the development of carbon markets and creating alternative value pathways for CO₂, with other entities prioritising the evolution of technologies and project efficiencies to more optimally deliver capture, transportation, storage or usage solutions.

The 'U' and 'S' in CCUS are competing demand pathways. CO₂ can't be permanently stored and utilised at the same time! Current policies and technologies are favouring storage, however, there is a growing level of activity for utilisation options for CO₂. This is particularly the case for biogenic CO₂ (i.e. CO₂ that is not derived from fossil fuel sources) as it offers the potential, for example, to be used in the production of sustainable, carbonneutral fuels.

It is widely accepted that achieving a net zero carbon emissions objective is impracticable without sources of negative emissions. CCUS clearly offers opportunities, but also costs, in this regard.

The Fuellers started life in carbon and it is exciting to see how our industry is continually evolving into the carbon markets of the future.



Fusion in Focus: Tokamak Energy, Global Strategies, and Technological Opportunities

Presentation by Robin Kamenicky, Senior Development Engineer, Tokamak Energy Ltd

Approximately thirty people attended the Fuellers Advantage Event, jointly held with the Energy Circle, at the National Liberal Club on 19 March 2025.

Initially, Robin Kamenicky presented some details about Tokamak Energy as a company. Tokamak Energy was an offshoot from the UK Atomic Energy Authority in 2009. It is a leader in the development of the tokamak type of fusion technology – using magnets to hold the plasma – which was first developed in Russia in the 1950s. The company is based in Oxfordshire and employs around 260 "brilliant people" with the aim of delivering fusion power in the 2030s.


Global electricity demand is growing significantly, particularly for data centres serving the ever-booming technology sector. With the rapid growth of Artificial Intelligence, the titans of the tech world – ever keen to progress their net zero targets and with mountainous ambition – are turning their attention to fusion energy, which seems rapidly to be moving to the radar screen as a destination for Silicon Valley's capital. Robin highlighted the sources of capital, including from international oil companies such as Shell and ENI, and an amount of around \$7 billion private investments worldwide to the year 2024.

Robin then went on to explain projects to build prototype fusion power plants in the US and the UK. With the UK's STEPproject aiming to demonstrate electricity to the grid by 2040 no less – fusion is certainly taking real steps forward! This project is part of a UK-led public-private funding program to build a prototype at the site of the former coal fired power plant at West Burton. The parallel approach of developing the science and the engineering for a fusion power plant was a most interesting insight from this presentation.

Tokamak Energy has many patents and has an interesting 'sideline' company called TE Magnetics which has developed high temperature superconductor technology applicable in various industries such as science and medicine, power systems, power distribution, and propulsion systems for land, water, air and space. Potential applications range from magnetohydrodynamic drive marine propulsion and zero emissions electric flight to magnetic resonance imaging and particle therapy for cancer patients. This is now an important part of the company's business.

Robin provided a fascinating overview of how Tokamak Energy and fusion more generally is progressing. The interest from 'big tech' is certain to drive much needed investment in research and the building of prototype projects. Tokamak Energy is now enabling spin-off technologies which could provide groundbreaking advances in areas such as marine propulsion for the defence industry. There are certainly many years to go before the water in our kettle will be boiled by fusion sourced electric - but with the drive and enthusiasm of engineers such as Robin Kamenicky - fusion power is starting to make giants leaps forward for humankind!

Governance

The Charles Stephenson Clarke Prize - City University

Many of the Trust's grants are in the field of education, and this annual prize is no exception. Named after the Company's founder Master, the prize is awarded for the best dissertation project(s) in the MSc Course in Energy and Environmental Technology and Economics at City University (now known as City St George's).

The three short-listed candidates gave a panel of four Fueller judges an eight-minute illustrated presentation on a variety of topics, including a lifecycle comparison of traditional and next-gen lithium batteries in EVs, the potential impact of phased transition to heat pumps in residential buildings in Luton and, the winning topic, an assessment of the reliability of Energy Performance Certificates when electric heating technologies can engage in demand side response.

Our winner is Jack Hailstone, who unfortunately wasn't able to attend the Affiliates Prize Giving at Trinity House in June, but we will attempt to unite Jack with his Certificate sometime in the future.

He said: "I am honoured to receive the Charles Stevenson Clarke Award from the Fuellers Charitable Trust. This recognition not only affirms my passion for energy innovation but also inspires me to continue striving for excellence in a field that holds such importance for our future. I'm grateful to the Trust for their insightful feedback on my project, and for the opportunity to be part of a tradition that uplifts education in the energy sector."

One by one, the citations were read beautifully by the Junior Warden, and our winner stepped forward to be presented with a Certificate by the Company's Principal Guest Vice Admiral Andy Kyte, Chief of Defence Logistics and Support, also receiving congratulatory handshakes from the Master, the Lady Mayoress and me.

Our Affiliates were followed by presentation of the Harrison Cup, and recognition of other prizes and scholarships funded by the Charitable Trust Fund.

AFSEA Affiliates Action Group

Dave Marsh, Liveryman and Military Affiliates Liaison

On 1 April at RAF High Wycombe, Members of the Worshipful Company of Fuellers were invited to take part in the inaugural AFSEA Affiliates' Action Group hosted by the Air Support Directorate.

The Air Fuels and Sustainable Energy Association (AFSEA) was set up in 2020 by the RAF and launched in 2021. Its aim is to bring all the parts of the energy community together across the defence and commercial sectors to centralise expertise and knowledge and share best practice. Looking to the future, AFSEA avidly promotes the development of sustainability concepts and policies within defence wherever possible, both in aviation fuels and other sources of energy supply. It also serves as a central hub for those with experience of working within the defence fuels sector as a communal networking space and social forum, hosting a range of social events and seminars throughout the year.

AFSEA has grown from strength to strength in the last half decade and now has a cumulative strength that has allowed it to celebrate its latest landmark. AFSEA formally launched the Affiliates' Action Group five years in the making, and on 1 April the Affiliates Action Group delivered its first session in support of the Air Support Directorate lead by Air Vice Marshall Shaun Harris CBE. The Air Support Directorate is part of the Support Force, which is responsible for delivering vital logistics, engineering, and enabling capabilities to support operations and exercises globally.

Blessed with participants from across the sector, including speakers from London Gatwick, Oclas Group, Rolls-Royce, and the Fuellers – their civilian counterpart. The dialogue was constructive and helped the Air Support team build a deeper understanding of what their new strategies can achieve in partnership with industry. Discussions included the fact that fuel and energy is now seen as an enabler and capability, not just a commodity. Alternative fuel types came under the microscope, encompassing small and micro nuclear, battery technologies, renewables harvested from in-theatre geography and climate and alternative liquid fuels, including synthetic air fuels (SAF) and hydrogenated vegetable oil (HVO).

Efficient use and delivery of various fuels and energy across the defence estate, and improved analytics to help improve this, was also explored, and of course the hot topic and very relevant question of national fuel and energy security was discussed in depth.

As AFSEA has stated: "The Affiliates Action Group is here to stay, supporting the UK Ministry of Defence's senior leadership in realising the potential of closer working relationships and harnessing the intelligence of our partners. Excellence through Unity".

The day was fascinating and useful, and I believe a great success, not in just supporting the Air Support Directorate and wider UK defence with a plethora of ideas and potential solutions to mull over, but also I feel, by way of building and enhancing relationships between the Worshipful Company of Fuellers, Industry, and our friends in the military.

The webinar was held by NEAH: New Energy Advancement Hub, with 235 registered participants, followed by several hundred views on LinkedIn.


